16 – 19 Student Financial Support offers support to students who may encounter financial barriers to learning, giving help towards the cost of travel, meals, equipment, educational visits and other course related costs. To be eligible to apply for 16 – 19 Financial Support you must be enrolled on a full-time study programme and:

- aged 16 or over but under 19 on 31/08/2022 or
- aged 19 24 on 31/08/2022 and have an Education, Health & Care Plan (EHCP) or
- aged 19 on 31/08/2022 and continuing a study programme you started aged 16 18 (19+ continuer)

Before you complete this form please read the information carefully and complete all sections that apply to you. If you are having any difficulty completing the form we are here to help and have a team in place to help you understand what funding you may be entitled to and answer any questions you may have.

Financial Support applications should be submitted along with supporting evidence no later than 4 weeks after the start date of your course. Support will start from the date you have provided all the information needed to assess your application. Back payments are not guaranteed and if you don't provide us with evidence of your household income we are unable to assess your eligibility for bursary support.

Priority support will be given to students with supporting evidence showing a household income below £35,000. If your household income is above this, please still complete a form as we may be able to take into account your individual circumstances and the cost of participating on your chosen course.16 – 19 Student Financial Support is available to students from the 16-19 Discretionary Bursary Fund and funded by the Education & Skills Funding Agency (ESFA).

Data Protection & Privacy

It may be necessary for additional supporting information to be sought from other college staff in order for a decision to be made. The College Privacy Statement will be sent to you via your college email account.

Further Information

16-19 Bursary is a cash-limited government fund administered by the college. The purpose of the fund is to provide partial financial aid to students who may have difficulty completing their course due to financial hardship. Students are not eligible to apply if they are:

- studying an apprenticeship programme or waged learning or training
- serving a custodial sentence
- released from a custodial sentence on temporary license
- who has been remanded to a secure institution

Bursary & Benefits

Receipt of bursary funding does not affect receipt of other means-tested benefits paid to families. However, if a student is in receipt of DLA (or PIP) and ESA, parents can no longer receive certain household/family benefits for that child, such as child benefit. Institutions are not permitted to make bursary fund payments as payments for living costs as this is out of scope of the bursary fund.

Appeals

Applicants have the right to appeal if they are not satisfied with any decision regarding bursary support or payments. Appeals must be made in writing and sent to:

If you have any mitigating circumstances please provide supporting evidence, for example doctor's note, hospital appointment etc. Appeals must be received within four weeks of the date you are appealing. The appeals panel will meet on a termly basis. We will inform you in writing with the outcome of your appeal. Please be aware the decision of the appeals panel is final.

Declaration:
